Chalcot Lodge makes every effort to keep the cost of items and activities to a minimum and affordable for all parents and the ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all you support, whether that's through fundraising or volunteering your time. This has made a huge difference to our school and the programs we can offer.

Without these contributions, the school would be unable to provide the comprehensive curriculum program that is currently available to students including the Well-being Program, STEM Program, coding and robotics, garden and kitchen classroom, Resilience Project (mindfulness) and to maintain a 1-to-1 ratio of devices.

Financial Support for Families

Chalcot Lodge understands that some families may experience financial difficulty and offers a range of support options, including:

- the Camps, Sports, and Excursions Fund
- individual payment plans

Camps, Sports, Excursion Fund (CSEF)

CSEF will be provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps, and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. The allowance will be paid to the school to use towards expenses relating to camps, excursions, or sporting activities for the benefit of your child.

The annual CSEF amount per student will be:

\$125 for primary school students

FREE INSTRUCTION
